

## TERMS & CONDITIONS

**PAYMENTS:** All application forms must be accompanied by a nonrefundable deposit of \$500 per person. Full payment is due September 3, 2010. Checks for the entire package should be made payable to Benny Hinn Ministries Travel & Tours. Benny Hinn Ministries Travel & Tours (BHM Travel & Tours) accepts VISA, American Express, MasterCard, and Discover. **LAND ARRANGEMENTS:** All sightseeing, as per itinerary, is aboard private motor coach with services of professional guide. Entrance fees to all sites, as per itinerary, are included. Please note: All the large cities have made an effort to accommodate those with disabilities over the past few years by installing ramps where possible in museums and church entrances. However there are still many restricted sites that cannot be reached with wheelchairs.

**SINGLE TRAVELERS:** Price per person is based on two persons sharing twin-bed rooms with private facilities in hotels and throughout the tour. Single rooms are limited but may be requested at time of booking for an additional charge of \$699. While single rooms provide privacy they are often smaller than twin rooms and are sometimes located away from the group in different areas of the hotel, and may be in high traffic areas such as stairways/elevators. We do not like to assess an additional charge for a single traveler and will make every effort (if you so desire) to match you with a same-gender roommate when we receive your application, but we do not guarantee a roommate can be matched. If a single room must be assigned due to your roommate's cancellation, incompatibility, or for any other reason (even at the last moment or while on tour), we must charge you the tour's single supplement or prorated amount. One partner in double occupancy wishing to move to a single-occupancy room at any time during the program will be responsible for paying both single supplements.

**LAND-ONLY PASSENGERS:** Passenger(s) arriving on flights other than BHM Travel & Tours flights must advise BHM Travel & Tours of their flight itinerary 2 weeks prior to departure. If the participants do not advise the tour company, he/she will not be accommodated on transfers to/ from the airport.

**AIR ARRANGEMENTS:** Packages are based on departure from specified gateway cities. Airfares are based on lowest available fares subject to change and fare restrictions. Deviations from the itinerary specified may result in a higher air fare. Airfare is subject to increases prior to date of travel. Airlines provide a block of seats for groups. All efforts will be made to seat families and traveling companions together. Individual seat requests can be made at time of check-in.

**DEVIATIONS:** Benny Hinn Ministries Travel & Tours will try to assist participants with changes in itineraries (All deviation requests must be submitted no later than September 3, 2010.) A deviation fee will apply plus an airline change fee per person. Routing and dates requested will determine if a difference in airfare will also apply. Please contact our office for detailed information.

**LATE REGISTRATION:** A \$100 fee and a possible increase in airfare may apply for bookings received after September 3, 2010. All space is subject to availability.

**LATE PAYMENTS:** A \$50 fee and increase in airfare or tour cancellation may apply to late payments received after September 3, 2010. Reservations are subject to deadlines with airlines and various vendors. Special delivery charges incurred will also be due in advance.

**TRANSFERS:** Transfers are seat-in-coach basis unless otherwise specified. Passengers arriving and departing independently will be able to arrange transfers through BHM Travel & Tours from/to airport at an additional cost. Although the airlines allow two pieces of luggage, we limit you to one suitcase and one carry-on, as the buses overseas cannot accommodate luggage in excess of this requirement.

**NOT INCLUDED:** Meals and beverages not specified in itinerary, some gratuities, airport taxes, optional tours, charges for passports, visas, vaccinations and inoculations, laundry, liquor, excess baggage charges, telephone or cable charges, private nongroup transfer, personal items, and any items not specifically listed as included.

**LAND SERVICE CHARGES:** All service charges and local taxes as imposed by hotels are included in the program rate. Your total tour price includes additional fees (subject to change) for basic tipping to your driver, tour manager/guide and to the local guides. Tips for the bus driver and tour manager/guide are normally given as a group at the end of the tour by a BHM representative. You and your bus group are welcome to bless at your own discretion, though doing so is not necessary.

**INSURANCE: INSURANCE IS INCLUDED IN THE FULL AND LAND-ONLY TOUR PACKAGE UNLESS YOU CHOOSE TO OPT OUT.** If you choose to opt out, we strongly recommend the purchase of travel insurance in order to protect your travel investment.

**TRAVEL DOCUMENTS:** A valid passport is required. Passport must be valid for at least six months following your return date. There is no visa requirement for citizens of the USA for travel to Israel. Other nationals or those intending to travel to additional destinations should contact the appropriate consulate for regulations. Please call a BHM Travel & Tours agent for visa requirements for other destinations. BHM Travel & Tours cannot process visa applications. BHM Travel & Tours is unaware of any inoculations that are required at press time for travel to Israel. You are strongly encouraged to check with local public health authorities for up-to-date information. BHM Travel & Tours will not be responsible for lack of current and valid entry documents.

**BAGGAGE:** Although the airlines allow two pieces of luggage, due to limited bus space, only one carry-on bag and one checked bag per person is allowed. The combined total dimensions of both bags are not to exceed 106 inches, and no one piece may be larger than

62 inches or exceed 50-70 lb., varying per airline. One piece of carry-on luggage is allowed, the total combined dimensions not to exceed 45 inches. All excess baggage charges will be collected at the airport. Policies may vary, and we suggest that you contact your airline directly before departure for current baggage dimension allowances. Baggage is at "own risk" throughout tour. BHM Travel & Tours is not responsible for lost or damaged baggage. Therefore, baggage insurance is strongly recommended.

**TRAVELERS REQUIRING SPECIAL ASSISTANCE:** All passengers must assure that they are medically and physically fit for travel and that such travel will not endanger them or others, as pilgrimages entail physical exertion. Any passenger who is physically challenged must submit a certificate from his/her medical doctor stating that he/she is capable of taking part in this pilgrimage without assistance. It is the responsibility of any traveler booking airfare or a tour to bring to the attention of BHM Travel & Tours any disability or physical challenge that may require special attention. This must be done at the time the reservation is made. BHM Travel & Tours will make reasonable attempts to accommodate the special needs of disabled travelers, but is not responsible for the services offered by hotels, restaurants, coach operator or other independent suppliers. A qualified friend, companion, or relative must accompany travelers who need special assistance.

Failure to provide such a companion may result in the termination of your participation in this tour. Be advised that most transportation services are not equipped with wheelchair ramps. We regret that we cannot provide individual assistance to a tour participant for walking, eating, boarding, or disembarking from coaches or other modes of transportation. **CANCELLATION:**

1. Cancellations must be received in writing to Benny Hinn Ministries Travel & Tours.
2. Cancellations received prior to September 9, 2010, forfeit \$500 per person.
3. Cancellations received on/after September 10, 2010, forfeit 100% of package price per person, including taxes, supplements, deviation fee, and any other costs incurred (if applicable). Special cases do qualify for refunds on the full tour package; please contact the travel insurance provider if your reason for cancellation qualifies under their protection plan.
4. Tour participation is nontransferable. Names cannot be transferred on reservations or airline tickets.
5. Special cases do qualify for refunds on the full tour package; please contact the travel insurance provider to inquire if your reason for cancellation qualifies under their protection plan.

**RESPONSIBILITY:** BHM Travel & Tours is acting solely as an intermediary agent for the travel suppliers providing means of transportation, hotel, and/or all other related travel services being purchased (the "Third Party Providers"). Therefore, you agree not to hold BHM Travel & Tours liable or responsible for any injury, illness, loss, or damage to any person or property or additional expense involved with travel resulting from acts of God, detention, annoyance, delays, quarantine, strikes, thefts, pilferage, force majeure, diseases, mechanical difficulties, failure of any means of transportation to arrive or depart as scheduled, civil disturbances, terrorism, government restrictions or regulations, and discrepancies or changes in transportation or hotel services or any other matter or event over which BHM Travel & Tours has no control; or for any state of quality, hygiene, political stability, cuisine, sanitation facilities, cleanliness, telecommunications facilities, methods of conducting business, emergency medical evacuation, treatment, or medical services existing at any travel destination. By embarking upon his/her travel, the passenger voluntarily assumes all risks involved with such travel, whether expected or unexpected. The issuance and acceptance of any exchange orders or tickets shall constitute consent by the purchaser and/or passenger to the foregoing conditions. All exchange orders and tickets are also subject to such additional terms and conditions as the Third Party Providers may impose. Finally, BHM Travel & Tours shall not be liable for any funds received from the purchaser and/or passenger and paid over to any Third Party Provider.

**SPECIAL NOTE:** Delays, cancellations, and overbooking by participating Third Party Providers may occur on air flights, boat rides, and land reservations. While BHM Travel & Tours will do its utmost to help avoid these inconveniences, it shall not be, and you agree not to hold it, liable or responsible for the acts or omissions of such Third Party Providers. BHM Travel & Tours reserves the right (i) to cancel any tour, substitute hotels, and make such alterations in tour itineraries as may be necessary or desirable for the convenience of the parties and the proper carrying out of the tour(s); and (ii) to decline to accept or retain any person as a member of any tour. All additional cost, if necessary, shall be the passenger's responsibility. In addition, BHM Travel & Tours may cancel any tour prior to departure. In such a case, a full refund of all payments shall constitute full settlement with the passenger and/or purchaser of the tour. All disputes arising under, in connection with, or incident to this agreement shall be litigated, if at all, in and before a court located in the city of Los Angeles, California, USA, and passenger agrees to submit him- or herself to the exclusive jurisdiction of any court of competent jurisdiction in such county. Retention of tickets, reservations or bookings by the purchaser and/or passenger after issuance shall constitute consent to the above terms, as well as an agreement on his/her part to convey the contents hereto to his/her travel companions or group members.
